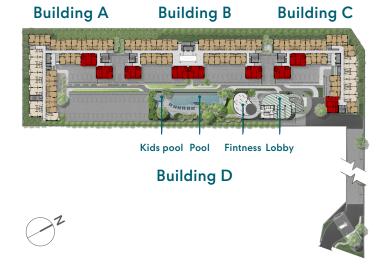

The Company's registered capital is 1,000,000,000.00 Baht, with paid-up capital of 400,600,000 Baht. The authorized signatories are Miss Wallaya Chirathivat and ITEL. Its Rep Dejchai. The project, named Escent Phuket (the "Project") is situated on Moo 5, PK. 4050 Rural Road, Wichit District, Mueang Phuket District, Phuket Province, with an approximate area of 6-1-90 Rai. The Project's land has servitude (partially) for walkways, car roads, electricity, water supply, telephone, and drainage pipes, including various public utilities both above and below ground, on land title deed number 119180, land number 604, in the same sub-district and district. The land is free of encumbrances. The Project's format is a residential building, 8 floors high, comprising 3 buildings and 2 floors high, comprising 1 building, with 514 residential units.
